Background

The Ministry of Economic Affairs and Communications of the Republic of Estonia together with other Baltic sea countries (Finland, Sweden, Norway, Denmark, Latvia, Lithuania, Poland) is developing cross-border services within the framework of the DIGINNO project for the Baltic Sea Region. 4 showcases were selected (cross-border KYC, eCMR, eReceipt, cross-border Business registration) of which in this conference we will introduce results of KYC and eCMR

DIGINNO (Digital Innovation Network) is a project funded by INTERREG Baltic Sea Region 2014-2020, which aims to accelerate the movement towards a single digital market and innovation in the Baltic Sea Region. One of the focuses of the DIGINNO project is the digitization of cross-border e-services in the G2B direction. The goal is to increase the volume of G2B cross-border e-services and raise awareness among public authorities, businesses and organizations

Introduction about KYC

Current know your customer (KYC) process is suffocating the economy, e.g. data exchange is slow and fragmented between different entities and non-existent across borders. The same data is asked again and again, it is not exchanged in between obliged entities and the State. Although the State has most of the data needed for conducting KYC, it is not accessible to the obliged entities. Billions of euros are spent on conducting KYC, but this outcome and work are not shared by others obliged entities.

Introduction about eCMR

Despite the ongoing uptake of digitization in the transport sector, almost 99% of all cross-border transport operations in the EU still involve paper-based Consignment note (CMR) at one or another stage of the operation. Both, European Commission and market players, indicate strong pressure towards more simplified, paperless, secured and trusted transport information flow between businesses, customers and authorities. There are e-CMR service providers and there are governments capable and interested to receive the data that they are entitled to check. Still, the governmental institutions cannot easily accept the electronic e-CMR due to lack of regulation and incompatibility of existing solutions. The missing link is the secure and trustful way to exchange e-CMR data between governments and e-CMR service providers.
